### EXCELLENCE IN EDUCATION

Deborah Gentry Davis has been selected to Co-chair the Panel with Kent Friel as Chairman.

Our April meeting was at the new Woodward Career Technical High School. Principal Larry Ballew and Community Coordinator Pamela Knox reviewed the operation of the 1,150 student school and discussed its successes and challenges. Of note were recent successes of students who rebuilt 4 New Orleans' houses and students completing half of their first college credits.

The Panel decided to change the selection process for the Jacobs Public Educator Award and Pepper Outstanding Volunteer Award to include guest (non- member) judges.

Mark Robertson is chairing a task force on Cincinnatus' collaboration with the STRIVE education initiatives. It was agreed these collaborations should include the Cincinnati Public Schools as well as those in Northern Kentucky. The task force will hold its initial meeting in April.

### **FOUR CIVIC GROUPS TO JOIN FORCES**

Gwen Robinson is spearheading participation in a powerful alliance's efforts to collaborate for more effective community service. Cincinnatus Association has much in common with Citizens for Civic Renewal, the Woman's City Club and the League of Women Voters. Besides sharing many members and volunteers, these four organizations are highly respected, well connected and have similar missions of public education and civic engagement. Initial considerations include: 1) development of a better civic engagement process in the City budget, using models of empowered citizen participation from other communities; 2) planning public education for Hamilton County regarding the jail; 3) communication and cooperation between issue committees of the four organizations; and 4) the potential for sharing resources and administrative items.

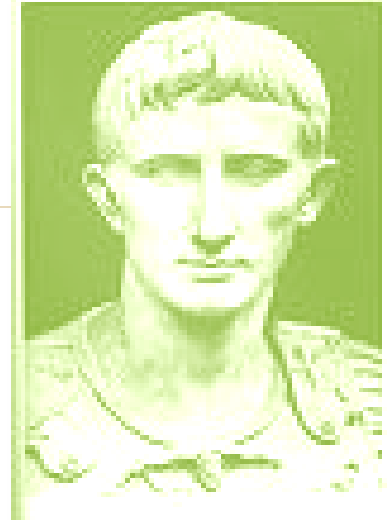
### **WEB MANAGEMENT GROUP**
